ABOUT MCC

The Minnesota Concrete Council (MCC) is a non-profit organization that was founded in 1989. MCC is dedicated to advancing education, technical practice, scientific investigation and research into cast-in-place construction by organizing the efforts of its members for a non-profit public service. MCC's membership base represents design, construction and support industries associated with reinforced and post-tensioned concrete construction. MCC is proud of its growing and diverse membership.
